Clearly indicate the conditions of the sale, including who is responsible for covering payments from inspection and evaluation services. Once the form of agreement is complete, the money in the deposit buyer account goes to the seller. There are several templates for online contract templates that may be suitable for your needs. These materials should also include details about any third parties who are helping in the sale of the game.
